1 Dear Judge Highberger,

2 This is joint submission on behalf of Plaintiffs and CalPERS regarding the status of the  
3 Settlement Agreement preliminarily approved by the Court on July 23, 2021. Because approximately  
4 30% of the settlement class opted out, the parties have determined that the existing settlement will not be  
5 going forward. The parties request that the June 8, 2022 hearing on final approval of the Settlement  
6 Agreement be taken off calendar.

7 The parties continue to work with the Hon. Layn Phillips (Ret.) to attempt to reach agreement on  
8 an amended settlement that would be acceptable to both CalPERS and the members of the class. In light  
9 of those attempts, the parties request that proceedings in this matter continue to be stayed until the next  
10 Case Management Conference, currently scheduled for May 9, 2022.


